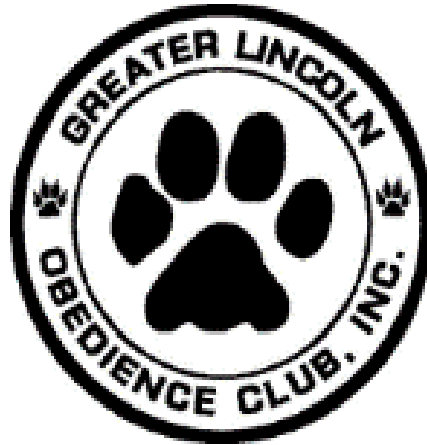

NOTICE TO EXHIBITORS

- *The safety of the dogs is the primary concern so by entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- *Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- *It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.
- *Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- *Requests for refunds after closing will be considered by the GLOC board (less \$6 admin fee and \$1.80 CPE recording fee per run). Request including rationale and supporting documentation must be submitted via email to gloctrialdirector@gmail.com within 7 days of the last day of the trial. A decision will be provided after the next GLOC board meeting (typically meets the first Thursday of the month).
- *Exhibitors are responsible for complete, accurate, and legible information on the entry forms. Any illegible or incomplete entries will not be entered in the trial.
- *Most of the building is air conditioned. Indoor crating is available with smaller rooms available for reactive dogs. Please bring mats to place under crates and chairs.
